Michigan repeal's anti-worker "right-to-work" legislation!

Thanks to union activists and labor friendly candidates, Michigan's Governor Whitmer signed a bill this spring that restored workers' freedom to organize by repealing "right-to-work." This is the first time this law has been repealed in 58 years! We constantly teach members that "What we legislate, we don't have to bargain," and that is the same message here. For the first time in decades, the power for the working class is turning in our favor. Last year our Michigan union members made it a priority to educate their locals on the importance of voting and elected many labor friendly candidates at the state and federal level. This shows us that when we mobilize our membership we win! Michigan union members have already started their next campaign with the hopes of banning mandatory anti-union campaigns performed by employers during organizing drives. Together we can make a difference and want to get our locals more involved. First Contracts bring Tremendous Gains for Members!

After two big organizing wins in the Jamestown, NY New Flyer bus parts facility and Plymouth Meeting, PA Visionworks retail location, IUE-CWA members got hard at work negotiating their first contracts. If organizing isn't hard enough, employers make it especially difficult to secure a first contract. After continued mobilization and perseverance at the bargaining table, our newest members secured tremendous gains in their first contracts!

The bargaining team in Jamestown, NY was able to secure increased wages with retroactivity back to January 1, 2023, all approved time off (vacations, holidays, union time, etc.) will count as time worked for overtime calculations, and a differential of \$1.00/ hr was added for bargaining unit members who meet specific eligibility requirements. The organizing committee is going strong, getting membership cards signed and keeping members motivated to stay Union Strong!

The bargaining team at Plymouth Meeting, PA Visionworks won a progressive discipline policy based on just cause, guaranteed wage increases, a grievance process including the right to arbitrate, locked in health care costs, safety, and health protections, and they are no longer at will employees. Members at the Plymouth Meeting, PA location are part of the growing IUE-CWA Local 81408.

IUE-CWA Sustainable Energy Solutions traveled to Local 84765 to hold an audit event June 25-27 at the Siemens Plant in Norwood, Ohio. This energy audit was challenging because we had been there before and much of the low hanging fruit was already captured. Thanks to the hard work of Local 84765 members, we were able to find almost 9% in annual utility savings through cost-effective projects. Most of these projects paid back in under 6 months. These savings add directly to the bottom line of a business-- no plant has ever closed due to making too much money! I would like to thank Local 84765 President Vic Henderson for making this event happen. Ohio "Vote No on August 8th, Issue 1" Special Election

This Summer, Ohio is facing one of the most consequential elections of a lifetime. This attack on voting rights, if passed, would require a 60% approved ballot measure by Ohio constituents rather than the current 50% majority needed. The proposed percentage would be an attack on workers and make it that much harder to fight back against right-to-work, changing minimum wage laws, and the list goes on. Our IUE-CWA members fought back and hit the streets. IUE-CWA Local 84775, 84755, and 84758 partnered with several community organizations to knock on doors, host phone banks, and participate in worksite actions. "It's important that not only our members know how detrimental this ballot measure could be, but the community needs to know as well," said Mike Gross (Local 84775 President). *While this article is being written, the fight continues. We won't know the outcome of this important election until this article is printed but will be sending out updates when we can.*

SAFETY 4 U

Storytelling can be a powerful tool for safety committees to teach safe and inclusive workplace. Sharing stories can connect us with others on an emotional level, helping foster empathy and understanding. By sharing individual experiences, members can gain a deeper appreciation for each other's experiences and perspectives, building stronger relationships and creating unity. Storytelling also allows members to share their struggles and triumphs, providing a platform for disregarded voices to be heard. By emphasizing diverse stories, safety committees can build a sense of belonging and ensure that every member feels valued and respected.

In addition, storytelling can be used in workplace safety training to educate and raise awareness about important workplace topics such as diversity, equity, and inclusion. Through narratives that address bias, microaggressions, or discrimination, members can gain insights into the challenges faced by others and develop strategies to create a more inclusive workplace.

Creating a safe workplace through storytelling involves building an environment where people feel comfortable, "safe," sharing their stories without fear of judgment or retaliation. Safety committees can encourage storytelling by providing programs or events for

members to share their experiences, such as training sessions, committee meetings, or dedicated events such as hazard recognition or a storytelling workshop.

How to identify hazards via sharing your story via mapping: Create a team, list the hazards commonly associated with the industry in which you work. Discuss how each item constitutes a hazard at your facility. If you don't know, ask if there have been any accidents from the hazards you identified. Then, based on shared stories, experiences, or facts make a drawing that shows the basic layout of your facility. Use a color-coded dot to identify the hazards in each area of the facility on the map. Rate each hazard on its severity. Label each hazard with a name or brief description. Finally, based on your map, discuss as a group which hazards are of most concern and how to best eliminate or lessen them.

Overall, storytelling can have an incredible power to etch a safety message in our minds, promote inclusivity, and raise awareness of important or harmful issues. By utilizing the power of storytelling workplaces can create an environment where each worker feels heard, valued, and supported.



The Power of Empowering

The committee, led by Angie Richardson reminds us that if someone near you goes into cardiac arrest, don't be afraid—just be prepared! The first 1-3 minutes of a cardiac event can make a difference. Chances are the local EMS can't be there that



fast. Heart attacks don't just happen at work, they can happen anywhere. You should consider training and being ready.

World First Aid Day, Sept 10th, is a day to remind us that it

pays to have first aid skills the whole year round so that you can be prepared in any situation. Basic First Aid, CPR, AED classes are free of charge and can be held at your Local Union Hall or at your represented business. NLRB Decides Atlanta Opera, Closing Loopholes in Independent Contractor Law

On June 13, the Board decided the Atlanta Opera case, overruling the Board's decision in the SuperShuttle (2019) case and reinstating the prior standard for evaluating whether workers are independent contractors or employees and thus covered by labor law. The issue at guestion in all three of these cases was whether certain workers should be considered employees or independent contractors, and therefore covered or not covered by the protections of labor law. This is an age-old question of our nation as our democracy has decided over the years to protect the rights of workers (employees). To avoid these protections employers have been very clever in creating legal loopholes to avoid employee rights (including labor law, overtime, minimum wage etc.), one loophole has been calling the employee an "independent contractor"

In the real world of course, independent contractors are sometimes truly and accurately called independent contractors. For example, when you call someone to repair your roof you generally do not (1) control the details of how they would fix your roof, (2) control whether or not they continue as a "roofing contractor" or do something else, (3) supervise them as a manager, (4) train them as a roofer, (5) supply all their tools as a roofer, (6) employ them as a roofer on a daily basis for years, (7) pay them by the hour instead of by the roof, (8) have a roofing business yourself, (9) consider yourself the roofing contractor's employer or vice versa, and (10) usually the roofer has their own business entity separate from you. In other words, an independent contractor is usually determined by these ten factors which are complex and detail oriented. These ten factors were established by common law and affirmed by the Supreme Court as the test for an independent contractor in the 1968 case United Insurance 390 US 254. These ten complex interrelated factors were never changed by the Supreme Court and certainly no one factor was placed above these ten factors.

Without any supporting precedent in 2019 the Board decided SuperShuttle DFW, Inc., 367 NLRB No. 75, which

elevated the test of "entrepreneurial opportunity" above the ten factors established by common law and affirmed by the Supreme Court. Under SuperShuttle DFW the control that the employer exercised over an employee became less important, and whether or not the employee has what is called "entrepreneurial opportunity" for gain and loss became a "super factor." What this allowed was for Companies to establish what they would call "franchise" or "independent contractor" agreements with individuals who had (1) no control over the details of the business (including prices, services, location, or schedule), (2) had specific assignments or routes given to them by the Company, (3) had Company supervision, (4) needed Company training, (5) had tools or equipment "leased" to them, (6) had no ability to take customers elsewhere or change services, and (7) had no true independence in the operational side of the business. However, all of these factors which under the older test would state that the worker was an "employee" would be overruled by the fact that they were paid on commission and therefore

and loss. The current Labor Board pointed out in Atlanta Opera that the SuperShuttle rule allowed empty "entrepreneurial opportunity" to overrule the clear control operated over the employee. For example, the Board pointed out that FedEx argued that its drivers were "independent contractors" because they could officially (on paper) hire employees to cover their route. However, the Board pointed out that FedEx had never proven that this actually happened, because FedEx had total control over the routes and FedEx had total control over the replacement. In other words, the "entrepreneurial opportunity" which FedEx utilized to keep calling their workers "independent contractors" was a thin disguise to avoid the protections guaranteed to workers.

Going back to the ten-factor independent contractor analysis established by common law and affirmed by the Supreme Court was the correct decision both legally and philosophically.

NLRB defends work-place speech rights rights

In an important recent decision, the National Labor Relations Board (NLRB) has once again proven its commitment to safeguarding the rights of American workers. The ruling in Lion Elastomer LP v. United Steel, Rubber, and Plastics Workers of America marks a significant return to the Board's role protecting the rights of bargaining unit members and officers in the context of union speech in the workplace.

The Board overturned an earlier precedent set by the Board during the Trump administration, in the General Motors case, which made it much easier for a Company to discipline officers and members who, in speaking out against contract violations or in favor of work-place improvements, ran afoul of shop rules against using profane or impolite language. The Board instead returned to long-standing precedent set in the Atlantic Steel case which established a four factor test to evaluate when an employee's foul or abusive language might be unprotected. This represents a step forward in promoting fair labor practices and fostering healthy employer-employee relationships:

- 1) *The Location of the Outburst:* this factor scrutinizes where the communication leading to the disciplinary action took place. An outburst away from work areas will be more likely to be protected.
- 2) *The Subject of the Discussion:* The NLRB evaluates whether the statements made in the context of a discussion of a grievance or contract rights.
- 3) *The Nature of the Employees Outburst:* the Board will find less offensive or extreme speech more likely to be protected.
- 4) Whether and to what extent the outburst was motivated by the Company's unfair labor practices: Outrageous or extreme outbursts are much more likely to be protected if motivated in response to the Company's unlawful conduct.

This decision is a welcome return to common sense in an area where the previous Board had significantly diminished the rights of our members and officers to be treated as equals in the context of discussions about grievances, work-place issues, and contract rights.

If called to a meeting with management, state the following to management when the meeting begins:

"If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative, officer, or steward be present at this meeting. - Until my representative arrives, I choose not to participate in this discussion."




